**CONSENT AWARD OF ARBITRATOR**

I, THE UNDERSIGNED ARBITRATOR, having been designated in accordance with the Arbitration Agreement entered into between the above-named Parties and dated June 19, 1995, and having been duly sworn, and the parties having agreed on the termination of these proceedings through correspondence between counsel dated August 18, 2006 and August 23, 2006, and having further agreed that such termination may be stated in the form of this CONSENT AWARD, do hereby determine and award as follows:

1. All claims in this case are hereby dismissed with prejudice, on account of the recent death of Mr. Louis B. Lloyd, who during life owned all legal shares of Claimant Belfinance Haussman, LLC, and upon the decision of the Claimant through the present-day successor to all such interest to withdraw from and terminate this arbitral proceeding, with prejudice.
2. The administrative fees and expenses of the International Centre for Dispute Resolution (ICDR) totaling FOUR THOUSAND TWO HUNDRED DOLLARS FIFTY DOLLARS ZERO CENTS (\$4,250.00) shall be borne equally by the Parties. In as much as the Claimant paid such fees and expenses in their entirety (\$4,250.00) at the inception of this proceeding, Respondent shall reimburse Claimant the sum of TWO THOUSAND ONE HUNDRED TWENTY-FIVE DOLLARS and ZERO CENTS (\$2,125.00), corresponding to Respondent's equal share of the administrative fees and expenses.

Additionally, the compensation and expenses of the arbitrator, totaling SIX THOUSAND EIGHT HUNDRED DOLLARS AND ZERO CENTS (\$6,800.00) shall be borne equally by the Parties. The ICDR shall refund to each Party the portion of its deposit exceeding THREE THOUSAND FOUR HUNDRED DOLLARS AND ZERO CENTS (\$3,400.00), which amount corresponds to each Party's equal share of compensation and expenses of the arbitrator.
